## **"Release and Hold Harmless Agreement"**

I further agree to indemnify and hold harmless and defend the Northfield Park District and its officers, agents, servants, and employees from any and all claims resulting from injuries, damages and losses sustained by me and arising out of, connected with, or in any way associated with the activities or the program."

## **Warning of Risk**
